Udug Association is a non-profit organization that promotes intercultural learning, human rights, active citizenship, volunteering, sport, and environmental protection. They also support youth cooperation in Europe. They work with youngsters to learn about cultural differences, modernity, and digitalization. They participate in Erasmus+ projects and other initiatives. They provide a space for local and international volunteers to meet, be creative, and work together.



Udug Association develops and promotes the Youth Action approach, which empowers and supports young people to take action to benefit themselves and others. Their youth projects are based on awareness-raising activities, intercultural activities, sport events, tournaments, conferences, training courses, youth exchanges, and campaigns. ### BEST PRACTISES



Promoting Intercultural Dialogue for Inclusion.

UDUG prioritizes intercultural dialogue tobridge the gap between migrant and host communities in Ireland. This practice fosters mutual understanding and collaboration to address challenges faced by migrant communities, promoting social cohesion and integration. For instance, UDUG organized "Intercultural Dialogue as a Way for Integration," a training program for youth workers on immigration and mobility fields, which was held in Vilnius in 2015 supported by Erasmus+ of European Union

Development

UDUG is committed to empowering
youth and community members by
equipping them with skills and
knowledge through non-formal
education and training. For example, the
"Training for Trainers for African
Diaspora Youth Workers" in Vienna in
2016 focused on social project
management for youth inclusion. These
initiatives build the employability and
leadership potential of migrants and
their descendants



Encouraging Youth Participation in Decision-Making

UDUG actively promotes youth engagement in civic and political life by raising awareness of voting rights and facilitating training on decision-making inclusion. A notable initiative was the voter registration training in Dublin in 2015, aimed at empowering young ethnic minorities to participate in the democratic process and have their voices heard in policy-making.
